Thank you for visiting the website of the Green Democratic Party Bihar. This Privacy Policy describes how the Green Democratic Party Bihar ("Green Democratic Party," "GDP" "we," "us," or "our") collects, uses, and discloses your personal information when you interact with our website <https://greendemocraticparty.org>, social media pages, or otherwise provide it to us.

1. Who we are

We are Bihar's First green Party Green Democratic Party founded by revolutionary Shri Arvind Msihra. Our website address is: <http://greendemocraticparty.org>.

2. What personal data Information we collect

We collect the following information from you:

Contact Information: Full Name, Email Address, Mobile Number, Whatsapp Number

Demographic Information: Voter ID No (optional), Age, Gender, Country, District, Full Address, City, Name of Your Assembly Constituency

Engagement Information: Message (Why do You Want to Join Us?)

Website Usage Information: We use Google Analytics, Bing Analytics, and similar tools to collect information about your visit to our website, such as the pages you view, the time you spend on the site, and the websites you visited before coming to ours. This information is collected anonymously and does not identify you personally.

3. How We Use Your Information:

We use the information we collect for the following purposes:

To process your requests and provide you with information about the Green Democratic Party, its activities, and upcoming events.

To personalize your experience on our website and social media pages.

To analyze website traffic and usage patterns.

To improve our website and social media content and outreach.

To send you occasional email updates and fundraising appeals (you can unsubscribe at any time).

4. Information Sharing and Disclosure:

We will not sell or share your personal information with third parties without your consent. However, we may share your information with third-party service providers who help us operate our website and social media presence, analyze website traffic, or send email newsletters. These service providers are contractually obligated to keep your information confidential and secure.

We may also disclose your information if required by law or to protect the rights and safety of ourselves or others.

When required by law or legal process.

When necessary to protect the rights, property, or safety of the Party, its members, or others.

With service providers who assist us in carrying out our operations (e.g., website hosting, email services), but only to the extent necessary to perform their functions.

7. Cookies and Tracking Technologies:

Our website may use cookies and similar tracking technologies to enhance your browsing experience and collect information about how you use our site. By using our website, you consent to the use of cookies in accordance with this Privacy Policy. Our website may use cookies to store information about your preferences and to personalize your experience. You can choose to disable cookies in your browser settings. However, this may limit your ability to use certain features of our website.

8. Security

We take reasonable steps to protect your personal information from unauthorized access, disclosure, alteration, or destruction. However, no website or internet transmission is completely secure.

9. Analytics and Advertising:

We use various analytics and advertising services, including but not limited to Google Analytics, Bing Analytics, Facebook Pixel, Meta Pixel, Twitter Analytics, Google AdWords, Google AdSense, and Bing Ads, to analyze website traffic and optimize our advertising campaigns. These services may collect information about your interactions with our website and other online platforms.

10. Data Security:

We take reasonable measures to protect the personal information we collect from unauthorized access, disclosure, alteration, or destruction. However, please note that no method of transmission over the internet or electronic storage is 100% secure, and we cannot guarantee absolute security.

11. Updates to This Privacy Policy:

We reserve the right to update or modify this Privacy Policy at any time. Any changes will be effective immediately upon posting the updated policy on our website. We encourage you to review this Privacy Policy periodically for changes.

12. Comments

When visitors leave comments on the site we collect the data shown in the comments form, and also the visitor's IP address and browser user agent string to help spam detection.

An anonymized string created from your email address (also called a hash) may be provided to the Gravatar service to see if you are using it. The Gravatar service privacy policy is available here: <https://automattic.com/privacy/>. After approval of your comment, your profile picture is visible to the public in the context of your comment.

13. Media

If you upload images to the website, you should avoid uploading images with embedded location data (EXIF GPS) included. Visitors to the website can download and extract any location data from images on the website.

14. Cookies

If you leave a comment on our site you may opt-in to saving your name, email address and website in cookies. These are for your convenience so that you do not have to fill in your details again when you leave another comment. These cookies will last for one year.

If you visit our login page, we will set a temporary cookie to determine if your browser accepts cookies. This cookie contains no personal data and is discarded when you close your browser.

When you log in, we will also set up several cookies to save your login information and your screen display choices. Login cookies last for two days, and screen options cookies last for a year. If you select "Remember Me", your login will persist for two weeks. If you log out of your account, the login cookies will be removed.

If you edit or publish an article, an additional cookie will be saved in your browser. This cookie includes no personal data and simply indicates the post ID of the article you just edited. It expires after 1 day.

15. Embedded content from other websites

Articles on this site may include embedded content (e.g. videos, images, articles, etc.). Embedded content from other websites behaves in the exact same way as if the visitor has visited the other website.

These websites may collect data about you, use cookies, embed additional third-party tracking, and monitor your interaction with that embedded content, including tracking

your interaction with the embedded content if you have an account and are logged in to that website.

16. How long we retain your data

If you leave a comment, the comment and its metadata are retained indefinitely. This is so we can recognize and approve any follow-up comments automatically instead of holding them in a moderation queue.

For users that register on our website (if any), we also store the personal information they provide in their user profile. All users can see, edit, or delete their personal information at any time (except they cannot change their username). Website administrators can also see and edit that information.

17. What rights you have over your data

If you have an account on this site, or have left comments, you can request to receive an exported file of the personal data we hold about you, including any data you have provided to us. You can also request that we erase any personal data we hold about you. This does not include any data we are obliged to keep for administrative, legal, or security purposes.

Visitor comments may be checked through an automated spam detection service.
